What is this product?

Type:

This Fund is a UCITS fund.

Term:

The Fund is open-ended and there is no determined maturity date.

Objectives:

The Fund has a sustainable investment objective through which it seeks to advance climate change mitigation and adaptation solutions. The Fund seeks to achieve long-term capital appreciation.

The Fund will invest primarily in equity securities of global small, mid and large capitalisation companies focused on climate change mitigation or adaption solutions in respect of the impact of climate change that has already occurred. In selecting and maintaining the Fund's holdings, the Investment Manager implements a framework to ensure that the Fund's investments qualify as sustainable investments and satisfy the "do no significant harm" test in accordance with the requirements of Article 9 of Sustainable Finance Disclosure Regulation ("SFDR").

The Fund is actively managed with reference to a benchmark. The Fund's performance benchmark is the MSCI All Country World Index-Net Dividends (with net dividends re-invested) (the "Benchmark"). The Benchmark is primarily used for performance comparison purposes but the Investment Manager may use the Benchmark as an initial indicative universe to select securities and to monitor certain risk information, which may include tracking error. The Investment Manager has broad discretion with respect to individual stock selection and may invest in securities that are not included on the Benchmark. The number of securities and weightings of those securities held by the Fund may deviate materially from that of the Benchmark.

The Fund may also gain exposure to equity related instruments such as common stocks, preferred stocks, rights and depositary receipts with a particular focus on securities the Investment Manager perceives to be aligned with the mandate of the strategy.

The Investment Manager will aim to build a relatively concentrated portfolio (typically 40 to 60 names) of public equity companies that appear positioned to perform favourably alongside global macro-economic and societal trends like global warming, technological innovation, middle class expansion, changing consumer preferences, increased regulation and urbanisation. The Investment Manager will generally focus on companies that derive a material or growing level of revenue from climate change mitigation or adaption products and services. Companies that meet this revenue criteria are considered for inclusion in the portfolio on a case by case basis through the application of the Investment Manager's "Six Key Characteristic" framework which focuses on six key areas of financial and climate solution based analysis.

The Investment Manager integrates sustainability risks into its investment decision-making for the Fund, which includes the assessment of potential sustainability risks associated with the purchase of investments.

The Fund may use financial derivative instruments ("FDIs") for efficient portfolio

management and hedging purposes in respect of hedged share classes.

The Fund may invest in convertible bonds on an ancillary basis which may be corporate, or government issued, fixed or floating rate and of any investment grade. The Fund may invest up to 10% of Net Asset Value ("NAV") in other collective investment schemes and eligible exchange traded funds. In exceptional market conditions or if the Investment Manager is of the opinion that there are insufficient opportunities to invest in securities, a substantial proportion of the Fund may be held in cash or invest all the Fund in liquid assets including cash equivalents.

The Fund may hold more than 20% of its NAV in emerging markets.

The Fund's base currency is USD.

The Class I3 GBP Acc Unhedged Shares are accumulating. All income and capital will be automatically retained within the Fund and reflected in the NAV per share.

You can buy and redeem Shares on each business day on which the banks in Ireland are ordinarily open for business and the New York Stock Exchange is ordinarily open for trading.

Depositary Bank: The Fund's assets are held with the depositary, Northern Trust Fiduciary Services (Ireland) Limited.


Intended retail investor:

This Fund is intended for investors seeking to achieve long-term capital appreciation through exposure to global equities and who are prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return. The Fund is not a complete investment program. You should carefully consider your own investment goals and risk tolerance before investing in the Fund.

Segregated Liability: The Fund is a sub-fund of Rockefeller Capital Management UCITS ICAV, an umbrella ICAV. Under Irish law the assets and liabilities of the Fund are segregated from other sub-funds within the ICAV and the assets of the Fund will not be available to satisfy the liabilities of another sub-fund of the ICAV

Conversion of Shares: A Shareholder may switch from one share class or one sub fund to another, free of charge. Notice should be given to the Administrator in such form as the Administrator may require. Please refer to the Prospectus for the Fund for further details on how to exercise your right to switch.

What are the risks and what could I get in return? Risk Indicator



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact the value of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The Fund may invest in securities which may, due to negative market conditions, become difficult to sell or may need to be sold at an unfavourable price. This may affect the overall value of the Fund. This Fund does not include any protection from future market performance so you could lose some or all of your investment.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
