## Sustainability approach

The Fund replicates as closely as possible the FTSE All-World ex CW Climate Balanced Factor Index (the "Benchmark Index"). The fund will have at least 90% exposure to assets that are included in the Benchmark Index. Details of the sustainability characteristics of the Fund and the Benchmark Index it replicates are set out below:

### 1. The Benchmark Index

The Benchmark Index methodology accounts for risks and opportunities associated with climate change. Specifically, it applies the following:

1. reduces exposure to companies that own or are engaged in the exploration or production of fossil fuels or the suppliers of equipment and services to the fossil fuel industry.
2. reduces exposure to companies that emit high levels of carbon dioxide relative to other companies in the same Industry Classification Benchmark sector.
3. increases exposure, determined by FTSE Russell's Green Revenues data model, to companies that produce goods, products and services that allow the world to adapt to, mitigate or remediate the impacts of climate change, resource depletion and environmental erosion. This list includes companies, which after certain period of engagement, continue to: (i) not perform well against LGIM's climate assessment; (ii) are unresponsive to engagement recommendations; and/or, fall behind in meeting LGIM's minimum standards. If the tracking deviation limit is exceeded, holdings of companies that are on the Climate Impact Pledge divestment list may be reduced rather than fully divested.
